## **PASSENGER CONTRACT: SCA & WSMR Alps Tour: August 30 – September 7, 2025\***

**\*Tour begins August 31 at Zurich Airport (ZRH)**

**GENERAL TERMS & CONDITIONS:** Please read this agreement carefully before sending any money.

**Covid-19:** For the health and safety of all tour participants, we ask passengers to use every precaution possible in protecting themselves from the effects of the Covid-19 virus. We strongly advise up-to-date vaccination. The Grand Tour reserves the right to update Covid-19 protocols for travel as governmental laws and regulations evolve.

**Tour Cost:** The price of the Sarasota Concert Association (SCA) - WSMR Alps tour is \$7,690 per person, ground only. This price is based on double-occupancy, and a minimum of 18 persons. Single supplement is \$1,845. See note under Accommodations on the reverse.

**Tour Cost Includes:** Seven (7) nights accommodations at a deluxe hotel in Lucerne • Prime tickets to 5 concerts, depending on ticket availability • Exclusive, pre-public hours tour and piano recital at the Wagner Museum, Tribschen • Breakfast daily; 5 lunches and 2 dinners, all including wine; plus a welcome reception • Private guided tours of major sites in the itinerary, with expert guides • Excursions from Lucerne to Mt. Rigi and Tribschen • Private motor coach and boat transportation for excursions mentioned in the itinerary • Private coach transfer to and from the airports for TGT/SCA & WSMR suggested flights • Private guides for all activities mentioned in the itinerary • Entrance fees for all scheduled visits to museums and other attractions • Services of TGT tour manager throughout the tour • All gratuities for meals, bus drivers, local guides and tour manager • Baggage handling for two pieces per person for hotel transfers • Departure packet of preparatory materials, including travel advice and reading list • Illustrated tour booklet • Map of Lucerne • Two SCA & WSMR luggage tags

**Tour price does not include:** Single supplement of \$1,845 • Travel to and from Europe and tour destinations • Meals and activities not offered as part of the tour • Alcoholic beverages not part of tour included meals • Tips for hotel room cleaning personnel • Personal expenses and purchases • Personal and travel insurance

**Reservations and Method of Payment:** The deposit for the tour is \$1,000 per person, and is first come, first served. Payment is accepted by check or money order made out to The Grand Tour, or credit card (Visa, MasterCard, or AMEX). *\$500 of the deposit is non-refundable.*

Upon receipt of deposit, The Grand Tour will send a letter of confirmation and travel insurance information. Prior to departure, additional items of interest will be mailed to the participants. Please note that tour participation is limited to 25 participants or as hotel space allows.

**Final Payment:** The final balance must be received at SCA & WSMR or The Grand Tour by Friday, June 27, 2025.

**Rates:** Prices quoted are based on costs in effect at the time of printing and are subject to change prior to departure. Prices could increase due to below minimum participation. Participants will be notified of any such price increase at least 30 days prior to departure.

**Cancellations:** You are entitled to a full refund if the tour is cancelled by SCA, WSMR or THE GRAND TOUR (TGT). If you should cancel, there is a non-refundable \$500 fee. The remaining balance (minus the \$500 fee) will be refunded according to the following schedule:

Before June 28, 2025:	100%, after \$500 is taken out
June 28 – July 12, 2025:	50%, after \$500 is taken out
July 13 – 27, 2025:	25%, after \$500 is taken out
After July 27, 2025:	0%

Notice of withdrawal from the tour must be communicated to The Grand Tour by e-mail: [info@thegrandtour.com](mailto:info@thegrandtour.com). All cancellations will be confirmed by The Grand Tour.

No refund will be made for features the passenger opts not to use. Once travel begins, any change made by a passenger is the responsibility of the passenger. Cancellation penalties caused by accident or illness to a passenger do not constitute waiver of applicable fees. Refunds will be processed within 90 days of receipt of cancellation notice. No person outside the group may participate in tour activities, including transportation and meals, unless he or she is admitted under the full tour cost.

**Itinerary or Program Modifications** While every effort will be made to adhere to the tour itinerary as planned, SCA, WSMR and THE GRAND TOUR reserve the right to modify the itinerary or programs at their discretion as warranted by circumstances at the time of the tour, including the right to substitute hotels of similar quality. In the event of any changes, SCA, WSMR and TGT will work to substitute programs of comparable value.

**Accommodations:** Hotels are chosen for comfort, location and character. Because some may be located in historic buildings, please be advised that not all rooms are alike and may differ in size. Specific room assignments are within the sole discretion of the hotel.

**Transportation:** Participants are responsible for booking air travel. However, The Grand Tour is happy to coordinate booking air travel for participants who need assistance. Participants arriving or departing on other dates or from other destinations will be responsible for meeting up with the group in Switzerland and for any fees incurred by these arrangements. The tour cost includes airport-hotel coach transfers for SCA/WSMR/TGT suggested flights. Neither SCA, WSMR, nor The Grand Tour is responsible for any expenses and/or damages incurred due to weather and/or flight delays. Any additional costs incurred outside of the set guidelines will be the sole financial responsibility of said traveler.

**Travel insurance:** As cancellation fees are strictly enforced, we strongly recommend for your protection that you purchase trip cancellation insurance. Travel insurance is also highly recommended in order to protect participants who must cancel or interrupt their trip due to illness or injury. Trip cancellation insurance is available, and information will be sent after your reservation is received.

**Responsibility:** The Grand Tour Travel Company, LLC, the Board of Sarasota Concert Association, WUSF Public Media, the University of South Florida, and their employees, shareholders, subsidiaries, affiliates, officers, directors or trustees, successors, do not own or operate any entity which provides goods or services for your program including, for example, lodging facilities, airline, vessel, or other transportation companies, guides or guide services, local ground operators, providers or organizers of optional excursions, food service or entertainment providers, etc. All such persons and entities are independent contractors. As a result, The Grand Tour, SCA and WUSF Public Media are not liable for any negligent or willful act, failure to act, financial failure or other defaults of any such person, entity, supplier or any other third party.

In addition and without limitation, The Grand Tour, SCA, and WUSF Public Media are not responsible for any injury, financial or other loss, death, inconvenience, delay, or damage to person or property in connection with the provision of any goods or services whether resulting from, but not limited to, “acts of God” or force majeure, such as regarding the Covid-19 virus, acts or orders of government, denial or delay of entry into any country, acts of war or civil unrest, insurrection or revolt, bites from or attacks by animals, insects or pests, strikes or other labor activities, criminal or terrorist activities of any kind or the threat thereof, sickness, illness, epidemics or the threat thereof, quarantine, the lack of availability of or access to medical attention or the quality thereof, mechanical or other failure of airplanes, vessels or other means of transportation, or for any failure of any transportation mechanism to arrive or depart timely or safely. Further, I release The Grand Tour, SCA, and WUSF from its own negligence and assume all risk thereof.

If due to weather, flight schedules or other uncontrollable factors, you are required to spend an additional night(s), you will be responsible for your own hotel, transfers and meal costs. Further, SCA, WSMR and The Grand Tour shall not be responsible for losses or additional expenses of the participant due to sickness, weather, flight schedules or other uncontrollable factors, strife, civil unrest, acts of terrorism, quarantine, “acts of God,” loss of baggage, or other causes beyond their control. Neither SCA, WSMR nor The Grand Tour is responsible for any expenses incurred regarding the Covid-19 virus, including but not limited to medical expenses, testing fees, quarantine, evacuation expenses, added air or hotel expense, etc., as a result thereof.

Under no circumstances is The Grand Tour obligated to refund the cost of any purchased travel insurance. The Grand Tour is not required to cancel any program for any reason including without limitation, United States Department of State, Centers for Disease Control, World Health Organization or other Warnings or Advisories of any kind. The Grand Tour is not responsible for fees assessed by air carriers resulting from operational and/or itinerary changes, even if The Grand Tour makes the flight arrangements or cancels the program. The Grand Tour reserves the right to substitute vessels, hotels or attractions of a similar category for those listed in this brochure. *NB: All participants who test positive for Covid-19 during the tour must isolate from the group, per CDC guidelines.*

**Miscellaneous:** The Grand Tour reserves the right to decline to accept or to retain any person as a member of the tour should the person’s health, actions, or general deportment impede the operation of the tour or the rights or welfare of the other participants. No refund will be made for any unused portion of the tour. *Please note that there is a moderate amount of walking on this tour. Participants must be able to walk unaided for up to 30 minutes. Tour staff will not have the resources to assist individuals who have mobility issues.*

**Forum.** Any dispute regarding these terms and conditions or the trip itself must be brought only in courts in and for the state of New Hampshire. For this specific purpose, the parties agree to personal jurisdiction and proper venue in such courts.
